1. It is informed to the applicants for the post of Library Attendant at this College in response to Advt. No. HRC/R(NTS)/005/2025 dated 16.01.2026 that they can check their status of screening of application on their dashboard on the recruitment portal at the following address, using their respective login ID and password:

2. The applicants who have any objections may represent through e-mail only to [ntsrecruitment2025@hrc.du.ac.in](mailto:ntsrecruitment2025@hrc.du.ac.in) with relevant documents in support of their claim within 10 days from the date of this notice, i.e., up to **14.07.2026**.

- 2.1 While mailing the representation, the candidate must ensure that the subject of the email should clearly indicate **the advertisement number, name, post and application form number**.

- 2.2 Further, the applicant will have to upload the requisite documents on their dashboard also, without which their representations will not be considered.

- 2.3 It is further clarified that document pertaining to the period after the last date of submission of the applications for the posts, i.e., 05.02.2026 will not be considered/ taken into account.

3. Following may be noted with respect to the screening status:

- 3.1 Screening Started – This implies that the applicant is eligible for being shortlisted based on the document(s) uploaded during submission of the online application. However, the number of candidates shortlisted shall be strictly as per the University of Delhi notification no. R&P/047/2018RR(NTS)2024/050 dated 21.10.2024.

- 3.2 Rejected – This implies that the applicant is not eligible for being shortlisted, based on the documents(S) uploaded during submission of the online application.

- 3.3 The reasons for rejection for screening is indicated against the appropriate section.

- 3.4 The applicant can represent against the screening status through the process indicated at Sr. No. 2. No hardcopy is required to be sent.

Representations received after the last date specified as Sr. No. 2 shall not be considered.

The decision of the College in all matters pertaining to the recruitment shall be final and binding. No correspondence /interim inquiries will be entertained from the candidates in connection with the process of selection / interview. Any dispute with regard to the selection/ recruitment process shall alone be subject to Courts having jurisdiction in Delhi.

4. The present notification is only with respect to the post of Library Attendant.

5. All communication related to recruitment process shall be uploaded on the College website (<https://www.hansrajcollege.ac.in>) from time to time. Hence, candidates are advised to keep looking at the College website for such information in their own interest.
6. The College reserves the right not to fill the advertised post and process of recruitment may be withdrawn at any point of time without assigning any reason. The College also reserves the right to offer deputation, temporary or contract appointments against the advertised posts.
