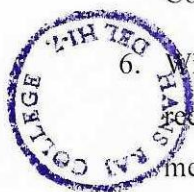

STANDARD OPERATING PROCEDURE (SOP) – DISCIPLINE AND CONDUCT

Hansraj College expects its students to be cultured, disciplined and well-behaved individuals. Every student is expected to contribute positively towards society and uphold the values and reputation of the College. These values form the foundation of the Hansraj College community.

In compliance with Ordinance XV (b) of the University of Delhi, Hansraj College, University of Delhi, hereby releases the **Standard Operating Procedure (SOP) – Discipline and Conduct**.

1. Resident students should take prior permission before bringing or facilitating the entry of outsiders into the college premises.
2. Students shall not, directly or indirectly, be involved in verbal altercations, physical fights, or threatening behaviour within the college premises.
3. Defamation of or damage to the reputation of the college through social media platforms (such as Instagram, Facebook, Print media, or any other platform), either individually or in association with outsiders is strictly prohibited.
4. Misbehaviour with teaching or non-teaching staff, either within/outside the college premises or through social media is not acceptable.
5. All elected student union members including the Central Councillor shall not be involved in any kind of indisciplinary activities such as misbehaviour with teaching or non-teaching staff, physical fights, verbal altercations, or defamation and damage to the College's reputation through social media.
6. Without prior permission of the competent authority, any kind of college-related video recording or statement/byte given by students to media persons, YouTubers, Print media, or others is not allowed within/ outside the campus. Additionally, any form of audio or video recording of classes or meetings, whether it is between administration or between teachers and students and student gatherings is strictly prohibited within the college premises.
7. Any kind of physical damage or defacement of college property is strictly prohibited.



8. Carrying/using, or threatening to use any kind of weapon in college premises is prohibited.
9. Any form of gender or caste discrimination and activities which can jeopardise the social harmony of institution is not allowed in the college premises.

All students must adhere to the above-mentioned SOP, failing which the College authorities may exercise the powers aforesaid and direct that any student(s) -

- a) be expelled; or
- b) be rusticated/ suspended, for a stated period; or
- c) be not admitted, for a stated period, to a course or courses of study; or
- d) be fined with a sum of rupees as decided by the competent authority; or
- e) be debarred from taking College Examinations for one or more years; or
- f) that the result of the student or students concerned in the examination or examinations in which he/she or they have appeared cancelled; or
- g) be declared ineligible to receive any prizes, awards, or felicitation from the College. Furthermore, such student(s) shall also be deemed ineligible to contest or participate in the Hansraj College Students' Union elections; or
- h) where any elected student union members are involved in any activities against the SOP, the student union may be dissolved with immediate effect.
