The receipt of applications for issue of tender documents should be supported by copies of self-attested credentials including registration with PAN, VAT, SERVICE TAX, PF, ESI, and Satisfactory Completion with Work Order and SOR.

The tender document shall be issued to the eligible firm on payment of non-refundable tender fees in cash/DD in favour of Principal, Hans Raj College of **Rs. 500/- (Rupees Five Hundred only)**

Pre-qualification requirements

The bidder should fulfil the following pre-qualification requirements:

- 1 The firms should be having valid registration with VAT No., SERVICE TAX, TIN No., PAN No., Registration with Industries or any other relevant document etc. at the time of application. And must produce these document at the time of Purchase of tender
- 2 The bidder must produce proof of completion of similar type of work in Govt./ Semi Govt./P.S.U./ Private sector of the at least One such work of cost of Rs. 11.2 Lakhs or Two works of cost of Minimum 7 Lakhs each or Three works of cost of Minimum 5.6 Lakhs each.
- 3 **Bidder should submit a certificate from OEM authorizing Firm (Bidder) to quote OEM's product for equipment installation for Fitness Centre specifically mentioning this work.** Authorization Certificate should be enclosed with pre-qualification documents. Vendor/ Bidder shall submit the certificate from OEM mentioning the continued supply of spare parts, repairing of faulty component over a minimum period of 5 years from the date of supply of the material.
- 4 Annual Turnover of the company shall be of minimum Rs. 70 Lakhs during any of the last **three** preceding financial year ending 31st March, 2016.

Earnest Money of Rs. 30,000.00 (Thirty Thousand only) by way of Demand Draft / Pay Order in favour of Principal, Hans Raj College payable at New Delhi to be deposited along with Tender documents. Tenders without Earnest Money are liable to be rejected.
