Principal Hansraj College University of Delhi, Mahatma Hansraj Marg, Malka Ganj Delhi-110007, invites proposal in sealed cover from experienced vendors engaged in rooftop solar projects with educational institutions in Delhi & preferably channel partners of M/s Tata Power Solar or reputed companies for

DESIGN, MANUFACTURE, SUPPLY, ERECTION,

TESTING AND COMMISSIONING INCULDING WARRANTY OPERATION & MAINTENANCE OF GRID CONNECTED ROOF TOP SOLAR, PHOTOVOLTAIC POWER PLANT in RESCO MPODEL under Virtual/group Net Metering Provision of Delhi Solar policy, 2017

RFP for 1Mw solar power plant for Hansraj College University of Delhi, Mahatma Hansraj Marg, Malka Ganj Delhi-110007, needs to be installed by bidder on Agricultural land in the Green belt areas of Delhi falling within the operation area of electric distribution agency M/s T.P.D.D. Ltd., under RESCO Model.

Indenting bidders, shall submit the proposals after study of all aspects, i.e. cost involved in arrangement of land in green belt area, all permissions and approvals of concerned authorities, net metering, design erecting, testing & commissioning including warranty, operations and Maintaince of solar power plant for a period for a period of 25 years.

Hansraj College University of Delhi will not bear any financial liabilities whatsoever except for purchase of solar power produced and supplied through TPDDL Grid to the Hansraj College University of Delhi. Solar Electricity producer shall have to make all arrangements to make Hansraj College University of Delhi, a beneficiary at site of plant, at their own cost. The bidder will only bill for solar power supplied to the Hansraj College through grid on per unit basis. Bidder will obtain permission from TPDL & bear the cost of arrangements for connecting Solar power to TPDDL Grid.

Bidders shall submit complete proposal along with the rate per unit inclusive of all taxes, payable by the college, terms and conditions etc. The rate should be valid and hold for 25 years without any escalation. College reserves its right to reject any or all proposals without assigning any reason. The College will be at liberty to cancel the agreement, if vendor/ bidder fails to supply Solar power due to any reason for continuous period of six months without any financial liabilities or compensations. Bidders shall enclose their company profile with list of experience in installations of Solar power plants especially giving list of educational institutions in last one year.

Last date for submitting the techno commercial bids along with proposed site(s) for installing Solar Plant in Sealed cover in the office of Principal Hansraj College by 18.02.2021 at 1200Hrs. This will be open on same day at 1230Hrs
