It's valuable, but if unrefined it cannot really be used. It has to be changed into gas, plastic, chemicals, etc., to create a valuable entity that drives profitable activity. So data must be broken down and analyzed for it to have value. With the rise of software, analyzing the data has become easy and quick and this has increased its utilization immensely. 
